



Rebuild, Restore, Recover LLC - Distributor

Terms and Conditions

Rebuild, Restore, Recover Distributor must fulfill all of the terms and conditions below. Where 'RRR' refers to Rebuild, Restore, Recover LLC

A. Price of Products:

- i. The price of the products for the distributor will be 25% off published price.
- ii. The distributor agrees to sell the products to the public at the same price currently published on the RRR retail price list.
- iii. Minimum Stock Requirement  
Minimum Stock agreement varies by area. RRR will determine minimum stock the distributor must have on hand to supply his/her area. Distributor agrees to abide by decision of RRR.

B. Product Agreement:

- i. Minimum amounts of products ordered monthly  
500.00 minimum order must be placed each month to retain distributorship privileges
- ii. Payment must be secured in total prior to shipping/releasing any of the products. The products will be shipped when the funds have been verified - Credit Card - approved, Personal Check - cleared, Money Order - funds confirmed.

C. Shipping and Handling:

- i. All products will be shipped via USPS Priority Mail (Flat Rate) with delivery confirmation/online tracking.
- ii. Shipping costs will be paid by the distributor

- D. Product Storage:
- i. All tinctures must be stored away from direct sunlight and in a cool place
  - ii. Powders such as Camu-Camu must be stored in a cool place, away from heat or direct sunlight. No freezing temperatures
  - iii. Teas and or Herbs must be stored at room temperature away from direct sunlight. Avoid humid places - dry cool places only
- These rules must be strictly adhered to. The risk lies with the distributor to answer for damages to any of the products. Products are inspected by RRR prior to shipping to the distributor to confirm quality. RRR will not replace damaged products.
- E. Return Policy:
- i. No returns are accepted
  - ii. Clients need to be advised of the policy and initial the order form acknowledging they have been advised of the policy
- F. RRR Seminars/Meetings- Sole Rights
- i. When RRR hosts a meeting in your area, selling of products is exclusively the right of the RRR LLC meeting facilitator(s). Distributors will continue to supply products as needed to the clients starting the 1<sup>st</sup> day of the week after the RRR series of meetings has ended -
- G. Termination of Distributorship Privileges
- i. Distributor agreement will be terminated if/when one of these conditions is breached. Sole discretion as to the termination of this agreement belongs to the owner(s) of Rebuild, Restore, Recover LLC
